## HEREBY DECLARES

that the packaging identified in **Annex A** complies with the applicable requirements of **Regulation (EU) 2025/40 (Packaging and Packaging Waste Regulation – PPWR)** and with any other applicable European Union legislation.

### Subject of the Declaration

This Declaration applies exclusively to dispenser boxes, cartons and bags identified by their respective packaging code. It is independent of the classification of the packaged product (medical device, PPE, food contact material or any other product category).

### Declared Compliance Requirements

Compliance has been assessed, where applicable, against the following requirements of Regulation (EU) 2025/40:

- limitation of the total concentration of lead (Pb), cadmium (Cd), mercury (Hg) and hexavalent chromium (Cr VI) to no more than **100 mg/kg**;
- hazardous substances present in the packaging;
- technical documentation and information received from suppliers throughout the supply chain.

### Harmonised Standards and Other Technical Specifications

As of the date of issue of this Declaration, no harmonised standards relevant to the declared requirements under Regulation (EU) 2025/40 are available. Compliance is supported, where applicable, by material technical specifications, suppliers' declarations, test reports and other technical documentation.
